Review Fees

Residential Development
Two lots or buildings \$50.00

In addition, the applicant or developer shall pay
a sum equal to 1/2% of the estimated costs of the
improvements to be installed including, but not
limited to, street, storm sewers, water facilities
and sanitary sewer facilities

Commercial or Industrial Development

Less than 5 acres \$400.00
Five to 10 acres \$500.00
Greater than 10 acres \$600.00

In addition, the applicant or developer of any residential,
commercial or industrial development shall pay a storm water management plan review
fee in the minimum amount of \$350.00; provided, however, that the fees required to be
paid for such review shall be the actual fees and costs accrued by reasons of the
Borough's Engineer and/or other professional consultants reviewing the subject

improvements and reporting thereon to the Borough, which fees and costs shall be charges made by the said engineer and/or professional consultant at the rate normally charged to the Borough for such services at the time that the same are performed

Inspection Fees .5% of the estimated costs of improvements to be installed.

All subdivisions or land developments involving the installation of improvements including, but not limited to, streets, storm sewers, water facilities, sanitary sewer facilities and any all other improvements, the applicant or developer shall enter into an agreement with the Borough providing for the creation of an escrow account for the inspection fees for said subdivision or land development

All review fees shall be paid at the time of filing of a preliminary plan for subdivision and/or land development.

The inspection fees shall be secured pursuant to an escrow account established under the developer's agreement and the fees required to be paid for such inspections shall be the actual fees and costs accrued by reason of the Borough's Engineer and/or other professional consultant at the rate normally charged to the Borough for such services at the time that the same are performed

The review and inspection fees shall be in addition to all other fees that may be required to be paid pursuant to the Subdivision and Land Development Ordinance [Chapter 22] or any other ordinances or resolutions of the Borough
